July 17, 2025

Chairman Lowell Clawson called this meeting to order at 5:03 p.m.

A motion was made by Seth Rauch and seconded by Dean Martin to approve the agenda of July 17, 2025, as presented. Motion passed.

Reports:

The Freightliner was towed to Rock Spring on June 23, 2025, By Stauffers Towing. Manager Sue Rigano stated the first tow company she called went out, but the wheelbase was too far back so they could not hook up to the truck. I had to go with another company.

The Freightliner was towed to Floyd's Trucking Center in Rock Springs.

Clerk-Manager Sue Rigano reported she rebilled the (2) past due customers and has received payment from one of them.

Clerk-Manager Sue Rigano stated she moved \$500,000. from our MMA account into our regular checking account on July 2, 2025. Cashed in Post Closure CD # 12393 and added \$10,000 to it, creating a new Post Closure CD # 101018 in the amount of \$116,031.65 matures in 12 months, this was done June 26, 2025. On June 22, 2025, The Bank of Commerce (at our request) combined CD# 100323 and Cd # 100346 together then added another \$500,000 to these two, setting the new maturity date as February 28, 2027.

Old Business:

Landfill Supervisor Jeff Evans updated the Board on the CDL Trainee.
We took one of our Trash Trucks into Rawlins parking it for CDL training for our employee.

A motion was made by Seth Rauch and seconded by Dean Martin to ratify a **No Charge fee for refrigerators and tires for the Town of Bairoil Clean up day scheduled for Saturday July 19, 2025.** Motion passed.

A motion was made by Dean Martin and seconded by Seth Rauch to pay bills Check # 20067 through Check # 20126 including all EFT's and all DC's in the amount of \$418,758.06. Motion passed.
